The first is intended for construction works where the Employer is responsible for the design as for per the previous so called Red Book 4th Edition 1987 with an important role for the Engineer. The other two conditions of contract are intended for situations when the Contractor is responsible for the design. The Plant and Design Build Contract has the traditional Engineer while the EPC Turnkey Contract has a two party arrangement generally with an Employer's Representative as one of the parties. The FIDIC Red Book Contract Christopher Seppälä, 2023-04-25 Conditions of Contract for Construction known universally as the Red Book published by the International Federation of Consulting Engineers known by its French acronym FIDIC is the most widely used standard form of international construction contract.
